Bachelor's Degree and a Corporate Membership at a Professional Institute in the field of Accounting or Finance or Financial Economics and being a Class I officer in an All-Island Service

OR

Bachelor's degree and a master's degree in the field of Accounting or Finance or Financial Economics with minimum of 07 years satisfactory service experience as a Deputy Director in TRCSL.

OR

Bachelor's degree and a Corporate Membership at a Professional Institute in the field of Accounting or Finance or Financial Economics with minimum of 07 years satisfactory service experience as a Deputy Director in TRCSL.
