SRI LANKA TELECOMMUNICATIONS ACT, No. 25 OF 1991

REGULATIONS made by the Minister of Posts, Telecommunications and the Media under Section 71 read with Section 6, of the Sri Lanka Telecommunications Act, No. 25 of 1991 as amended by Act No. 27 of 1996.

Regulations

1. These Regulations may be cited as the Telecommunications (Technical Examinations) regulations No. 6 of 1999.
2. The Commission shall conduct the following examinations for the purpose of establishing and maintaining technical standards as may be necessary for the purpose of providing an adequate and efficient telecommunication service :
 - (i) Global Maritime Distress and Safety Systems (GMDSS) Restricted Operator's Certificate (ROC) examination.
 - (ii) Global Maritime Distress and Safety Systems (GMDSS) General Operator's Certificate (GOC) examination.
3. A candidate who desires to sit for any of the examinations referred to in regulation 2 shall submit an application to the Commission in such form as may be provided by the Commission, with the appropriate examination fee as specified in Schedule I.
4. The certificate to be issued to any candidate who reaches the required level of proficiency at the examination referred to :-
 - (a) in regulation 2(a) shall be as set out in Schedule II ; and
 - (b) in regulation 2(b) shall be as set out in Schedule III.
5. In these regulations, unless the context otherwise requires :-

"Commission" means the Sri Lanka Telecommunications Regulatory Commission of Sri Lanka established under the Sri Lanka Telecommunications Act, No. 25 of 1991.
