- Bidding will be conducted through National Competitive Bidding 3. (NCB) Procedure under Standard Bidding Document of NPA/Goods/SBD 01 and Government Procurement Guidelines.
- To be eligible for Contract Award, the successful bidder shall not have been blacklisted and shall meet the following requirements:
 - Registered with the Construction Industry Development Authority (CIDA) for Furniture, Fittings & Equipment (FF&E) - Grade SP3 or above

- **b)** Registered as a business entity in Sri Lanka as a manufacturer of furniture or authorized agent for supply of furniture and have experience for last consecutive five (05) years
- 5. Qualification requirements to qualify for contract award shall be,
 - Average annual turnover of interior works or supply or manufacture and supply of furniture performed during any three (03) years within the last five years shall be at least Rs. 31 million.
 - Successful completion of a supply of furniture in one contract of value Rs. 20 million within 6 months or higher value within proportionate time period, during last 5 years.
 - The minimum amount of liquid assets (after setting apart for other contractual commitments) and exclusive of any advance payment which may be made under this Contract, shall be not less than Rs. 10.5 million.
 - Possess a valid certificate issued by the Registrar of Public Contracts in accordance with Section 8 of Public Contracts Act No. 03 of 1987, if the contract value exceeds Rs.5 million.
- A complete set of Bidding Documents in English language may be 6. purchased by interested bidders on the submission of a written application to the Director (Administration and Corporate Affairs), TRCSL from 09.10.2025 until 22.10.2025 between 0900 hrs. and 1500hrs. upon payment of a non-refundable fee of Rupees Five Thousand (Rs 5,000.00). The method of payment shall be in cash.
- 7. Duly completed bids shall be delivered and deposited in duplicate in the Tender Box available at the office of the Administration Corporate Affairs Division at the above address to reach at or before 1400 hrs. on 23.10.2025. Late Bids will be rejected. Bids will be opened soon after closing the bids, in the presence of the bidders' representatives who choose to attend.
- All bids shall be accompanied by a "Bid-Security", of Sri Lankan 8. Rupees Two Hundred and Ten Thousand (LKR 210,000.00) obtained from a commercial bank operating in Sri Lanka approved by the Central Bank of Sri Lanka. This Bid Security shall be in the format specified in the bidding document and shall be valid up to. 05.02.2026.
